The Grant County Drainage Board meeting was held April 27, 2021 in the Grant County Council Chambers. Mark Bardsley, Chairman, called the meeting to order at 11:04 a.m. Other members present were Kenny Cates, Pat Pinkerton and Grant County Surveyor Jim Todd. Gordon Gough and Richard Cox were not in attendance.

## APPROVAL OF MINUTES:

Kenny Cates made a motion to approve the April 13, 2021 minutes; seconded by Mark Bardsley; motion carried 2-0. Pat Pinkerton abstained since he was not in attendance for the April 13<sup>th</sup> meeting.

Jim Todd added that Mr. Nelson has a contractor that he would like to do the work; Jim informed Mr. Nelson that the contractor would need to send Mary Weesner a certificate of insurance before that could be allowed. Trees will need to be pulled up to the high ground so that they will not float back in.

Ludlum of Lugar Creek – Amy BeBe; \$163,559.31 (collecting)

Jim Todd stated that Mrs. BeBe is requesting to brush and dredge the Ludlum Branch of Lugar Creek. If the Board approves this request, Jim will contact the contractor and have this put on their list. Kenny Cates made a motion to authorize the brushing on the Ludlum Branch of Lugar Creek; seconded by Pat Pinkerton. Motion carried 3-0.

Mark Bardsley that he would like to extend his condolences to Drainage Board secretary, Mary Weesner for the loss of her mother and will continue prayers for the family.

Mark added that he is continuing prayers for healing for Board Vice-Chairman Gordon Gough following his stroke.
